

**AMENDMENT TO H.R. 5743, AS REPORTED
OFFERED BY MR. HINCHEY OF NEW YORK**

At the end of title III, add the following new section:

1 **SEC. 306. REPORT ON ACTIVITIES OF THE INTELLIGENCE**
2 **COMMUNITY IN ARGENTINA.**

3 (a) IN GENERAL.—Not later than 270 days after the
4 date of the enactment of this Act, the Director of National
5 Intelligence shall submit to the appropriate congressional
6 committees a report containing the following:

7 (1) A description of any information in the pos-
8 session of the intelligence community with respect to
9 the following events in the Republic of Argentina:

10 (A) The accession to power by the military
11 of the Republic of Argentina in 1976.

12 (B) Violations of human rights committed
13 by officers or agents of the Argentine military
14 and security forces during counterinsurgency or
15 counterterror operations, including by the State
16 Intelligence Secretariat (Secretaria de
17 Inteligencia del Estado), Military Intelligence
18 Detachment 141 (Destacamento de Inteligencia
19 Militar 141 in Cordoba), Military Intelligence
20 Detachment 121 (Destacamento Militar 121 in

1 Rosario), Army Intelligence Battalion 601, the
2 Army Reunion Center (Reunion Central del
3 Ejercito), and the Army First Corps in Buenos
4 Aires.

5 (C) Operation Condor and Argentina's role
6 in cross-border counterinsurgency or counter-
7 terror operations with Brazil, Bolivia, Chile,
8 Paraguay, or Uruguay.

9 (2) Information on abductions, torture, dis-
10 appearances, and executions by security forces and
11 other forms of repression, including the fate of Ar-
12 gentine children born in captivity, that took place at
13 detention centers, including the following:

14 (A) The Argentine Navy Mechanical
15 School (Escuela Mecanica de la Armada).

16 (B) Automotores Orletti.

17 (C) Operaciones Tacticas 18.

18 (D) La Perla.

19 (E) Campo de Mayo.

20 (F) Institutos Militares.

21 (3) An appendix of declassified records reviewed
22 and used for the report submitted under this sub-
23 section.

24 (4) A descriptive index of information referred
25 to in paragraph (1) or (2) that is classified, includ-

1 ing the identity of each document that is classified,
2 the reason for continuing the classification of such
3 document, and an explanation of how the release of
4 the document would damage the national security in-
5 terests of the United States.

6 (b) REVIEW OF CLASSIFIED DOCUMENTS.—Not later
7 than two years after the date on which the report required
8 under subsection (a) is submitted, the Director of National
9 Intelligence shall review information referred to in para-
10 graph (1) or (2) of subsection (a) that is classified to de-
11 termine if any of such information should be declassified.

12 (c) FORM.—The report required under subsection (a)
13 shall be submitted in unclassified form, but may include
14 a classified annex.

15 (d) APPROPRIATE CONGRESSIONAL COMMITTEES
16 DEFINED.—In this section, the term “appropriate con-
17 gressional committees” means the Permanent Select Com-
18 mittee on Intelligence and the Committee on Appropria-
19 tions of the House of Representatives and the Select Com-
20 mittee on Intelligence and the Committee on Appropria-
21 tions of the Senate.
